Bylaw #331-18

A Bylaw to Repeal Municipal Committees

WHEREAS Section 220 of the *Municipal Act*, being Chapter 154 of the Revised Statutes of the Yukon 2002 and amendments thereto, states "The power to pass a bylaw or a resolution includes the power to amend or repeal the bylaw or resolution unless this or any other Act expressly provides otherwise"

NOW THEREFORE the Council for the Village of Haines Junction, duly assembled, hereby enacts as follows:

SHORT TITLE

1. This bylaw shall be cited as the "Committees Repeal Bylaw".

INTERPRETATION

- 2. In this bylaw, the following terms are defined as follows:
 - a. Administration means the Administration of the Village of Haines Junction.
 - b. Committee means a committee established by an order of Council of the Village of Haines Junction to include and is limited to mean: Arts Acquisition Selection Committee, Community Development Committee, or Culture, Parks, and Recreation Committee.
 - c. Council means the elected Council of the Village of Haines Junction.
 - d. Municipality means the Municipality of Haines Junction
 - e. Project Manager a person appointed by Council to coordinate the completion process of a project transferred to the Administration from a Committee.

PROVISIONS

- 1. All projects currently underway by the Art Acquisition Selection Committee, Community Development Committee, and the Culture, Parks, and Recreation Committee shall be transferred to the Administration until such time as the project is completed or the project is brought to a close through an Order of Council.
- 2. Council may at its sole discretion appoint a person or persons from each Committee to act as a Project Manager(s) to oversee the completion process of any projects transferred to the Administration from that Committee.
- 3. All unspent funding allocation previously set aside for all committees shall return to general revenues of the Municipality.
- 4. The Project Manager shall work closely with and report to Council via the Administration.
- 5. The appointment of a Project Manager shall expire at the completion of the project as determined by Council or immediately after the project is brought to a close through an Order of Council, for which the appointment was made.

ENACTMENT

- 8. This bylaw shall come into full force and effect upon the final passage thereof.
