SECTION 5 - FINANCE

URBAN ELECTRIFICATION

FIN 002 - 04

WHEREAS Council of the Village of Haines Junction acknowledge that some municipal taxpayers may require assistance from the municipality in providing funding for electrical services to their property, similar to other local improvements,

NOW THEREFORE, the Council is prepared to assist such property owners, based on the following criteria;

- 1. Bylaw funding for the electrification of property shall not exceed a total principle amount of \$ 25,000 (twenty five thousand dollars) to any one property owner.
- 2. The minimum Bylaw funding for the electrification of property, as per above, shall be \$10,000 (ten thousand dollars).
- 3. The term of the local improvement shall not exceed ten (10) years of annual payments.
- 4. Interest shall be charged at a rate of business prime plus two percent at the time of funding.
- 5. The cost of the service shall not be more than 75% of the assessed value of the property and improvements.
- 6. Written cost and details of the proposed service must be received from the Yukon Electrical Company Limited.
- 7. The property owner will pay the required deposit to the Yukon Electrical Company Limited prior to final reading of the local improvement bylaw.
- 8. Service from Yukon Electrical Company Limited will be obtained by P.O. from the Village with payment on completion of the work.
- 9. An annual budget and a reserve amount shall be established by Council and no applications will be considered that may exceed the annual budget or the reserve amount.
- 10. Application for this local improvement benefit will be made to Council on the forms provided by the municipal office.
- 11. Other conditions, restrictions or variances to this policy may be determined by Council in considering any individual application.
