PROCEDURE

The judging shall be completed by December 20th of each year.

Notice of the contest shall be advertised so that as many citizens as possible are made aware of the contest and prizes.

Notice of the winners shall be circulated in the community as soon as possible after the judging.

RESPONSIBILITY

IT IS THE RESPONSIBILITY OF THE CPR COMMITTEE TO JUDGE AND ADMINISTER THE ANNUAL CONTEST EITHER BY THE COMMITTEE AS A WHOLE OR DESIGNATED MEMBER(S).

PROCEDURE

THE JUDGING SHALL BE COMPLETED BY DECEMBER 20TH OF EACH YEAR.

NOTICE OF THE CONTEST SHALL BE ADVERTISED SO THAT AS MANY CITIZENS AS POSSIBLE ARE MADE AWARE OF THE CONTEST AND PRIZES.

NOTICE OF THE WINNERS SHALL BE CIRCULATED IN THE COMMUNITY AS SOON AS POSSIBLE AFTER CHRISTMAS.

Purpose

In the spirit of Christmas Council and the Culture, Parks and Recreation Committee wish to promote and reward citizen participation in an annual yard decorating contest.

Responsibility

It is the responsibility of the Culture, Parks and Recreation Committee to administer the annual decorating contest either by the Committee as a whole, a single member or a designate.

Procedure

- 1. The judging should be completed by December 20 of each year.
- 2. Notice of the contest should be published so all citizens are made aware of the contest and prizes.
- Notice of the winner shall be published as soon as possible after Christmas in the St. Elias Echo.
- 4. The prizes will be limited to first prize cash award of \$50.00 and a honourable mention of the second place winner. The winners name will be engraved on a plaque to be displayed in the Village office.
- 5. The distribution of the awards will be administered by the Village administration staff.
