



Project Scope - Summary:

The Project is the improvement of an existing access road and the construction of a right-of-way to private property at km 202.4 on the Haines Road. The Project falls within the Traditional Territory of Champagne and Aishihik First Nations. Project activities will take place a minimum of 190 m from Dezadeash Lake and work is planned to occur from September 1 to October 15, 2023 or between July and October of 2024 depending on permitting. The use and maintenance of the private lot and access are indefinite.



Project Scope - Activities:

- Use of heavy equipment
- Minimal clearing by hand (happening outside of bird nesting season)
- Improvement of an existing access road (approximately 800 m long x 3 m wide)
 - Gravel and silt supply to be delivered by truck:
 - YG source at km 200.6 (130 m3)
 - From private property (10 m3)
 - Leveling and grading
- No fuel or heavy equipment stored on-site
- Woody material (approximately 7 m2) to be hauled to private land and chipped or burned
- Burning occurring between November and March

Senator Pat Duncan Yukon June 2023



When at work in the Senate, my thoughts are not very far from home and Yukoners.

During the busy spring sitting, I was able to tribute Mary Merchant, welcome Yukon Rangers to Ottawa, and speak to legislation directly and indirectly affecting the Yukon.

Since officially taking my seat in the Senate in February 2019 I have appreciated serving on the National Finance Committee (NFFN). This Committee is charged with reviewing all the financial initiatives of the Government including the spending in the budget documents, and new and special tax measures.

This year, the Budget Implementation Act (Bill C-47) included an amendment to the Yukon Act. Part 4, Division 20 transfers authority over the land at the Faro Mine site, notably the remediation, from the Government of the Yukon back to the Government of Canada. You can review my speech on the amendment here.

You may have noted I mentioned in my last newsletter my service with the Senate Committee on Agriculture and Forestry. In addition to hearing from Yukoners on the long-awaited soil health study, the committee has in recent months held 25 meetings, hearing expert testimony from over 95 farmers, producers, scientists, and policymakers. The study on soil health will continue with planned visits to Saskatoon and southern Alberta in late August.

Senators are able to attend any committee meetings they wish, however, I will not be able to attend these Agriculture and Forestry Committee site visits this summer, or continue in the fall as an active member of this or the National Finance Committee. Their meeting schedule conflicts with my recent appointment to the National Security and Intelligence Committee of Parliamentarians (NSICOP). The public reports of the Committee NSICOP including the most recent 2021 Annual Report are available online here.

In addition to my responsibilities on NSICOP, I look forward to joining the Fisheries and Oceans Committee in the fall. I especially anticipate bringing the issues of Yukon River, generally west coast, salmon to the attention of this group.

Ottawa and the Senate can seem very far away. Please know the Yukon and you – Yukoners – are not far from my attention. I am so looking forward to reconnecting this summer. I do look forward to seeing folks in person, and always look forward to hearing from you by telephone, email, and postal mail. Enjoy the Yukon summer!

2023 is the 70th Anniversary of the Korean War armistice. On June 24th, my colleague Senator Yonah Martin, Grand Patron of the Korea Veterans Association Heritage Unit, hosted a dinner honouring the veterans. I was especially grateful to have met Don and his wife of 65 years Laurette. Don served with the Canadian Corps of Engineers in Korea and served in the Yukon when Canada took over the Alaska Highway from the Americans, in 1947. It was such a privilege to hear a few of Don's memories of his service in the Yukon.

Ryan Sealy and Peter Zwikirsch are two Yukon Rangers who travelled to Ottawa to honour Korean War Veterans and commemorate the 70th anniversary of the armistice. Thank you, Ryan and Peter for your service.





I was honoured to attend the first in-person citizenship ceremony in several years on Canada Day at the Historic Site of the SS Klondike, an iconic Whitehorse landmark. It was such a moving and inclusive ceremony. The Yukon welcomed new citizens from five different countries.

Of Note in the Senate

Bill C-224, An Act to establish a national framework for the prevention and treatment of cancers linked to firefighting.

This Private Members' Bill, which came to the Senate from the House of Commons this spring, is an attempt at protecting firefighters throughout Canada from cancers cause by various chemicals they are exposed to in their daily work, including from their protective gear and clothing.

The bill provides for the development of a national framework designed to raise awareness of cancers linked to firefighting with the goal of improving access for firefighters to cancer prevention and treatment. This national framework is needed because some provinces and territories recognize as many as 20 different types of cancers linked to firefighting, others recognize only 9 types of cancers.

The bill also designates the month of January, in each year, as "Firefighter Cancer Awareness Month" to shed light on the serious challenges faced by those who are there to save our lives and property in times of need.

My colleague in the Independent Senators group Senator Hassan Yussuff, sponsor of the bill said: "Workers don't go to work expecting to die, but that's exactly what is happening to our firefighters — at an alarming rate — in every community across this country because of the consistent exposure to high levels of carcinogens that may lead to cancers."

This bill became law on June 22, 2023

Bill S-254, An Act to amend the Food and Drugs Act (warning label on alcoholic beverages)

Bill S-254, introduced by Senator Patrick Brazeau, is a Senate Public Bill that amends the Foods and Drugs Act to make warning labels on alcohol sold in Canada mandatory. These labels must include: how much of a drink is considered a standard drink, how many standard drinks are in a package, how many standard drinks can be consumed before causing significant health risks, and a clear message showing a direct link between alcohol consumption and cancers.

On June 1, I spoke in support of the bill at second reading to highlight the Yukon experience with the Northern Territories Alcohol Labels Study that started in 2017. Sales of alcohol products with labels decreased and sales of alcohol products without the labels increased. Just as we read labels in the grocery store on various products, Bill S-254 is about ensuring consumers are aware of the health information associated with the products they are consuming.

Bill S-254 was adopted at second reading and referred to our Social Affairs, Science and Technology Committee for study anticipated to take place this fall. You can view my speech on the bill here.



Of Note in the Senate

Bill C-18, An Act respecting online communications platforms that make news content available to persons in Canada

The Online News Act establishes rules for the digital news marketplace to ensure fair compensation for Canadian media outlets and journalists for content posted on social media platforms like Facebook and Twitter. It creates a new legislative and regulatory framework that ensures digital platforms negotiate agreements with Canadian media to authorize them to share Canadian media content on their platforms. The bill sets up a process that enables smaller media outlets to bargain collectively. Simply put, the large online companies, who make billions of dollars in annual revenue, have to pay creators of news for their work.

Bill C-22, An Act to reduce poverty and to support the financial security of persons with disabilities by establishing the Canada disability benefit and making a consequential amendment to the Income Tax Act

The Canada Disability Benefit Act creates the Canada disability benefit to reduce poverty and to support the financial security of working-age persons with disabilities. The bill also sets out general provisions for the administration of the benefit and authorizes the government to implement most of the benefit's design elements through regulations.

This was another bill that became law on June 22, 2023.

Bill C-21, An Act to amend certain Acts and to make certain consequential amendments (firearms)

During Question Period in the Senate Chamber on May 31, I had the opportunity to ask Hon. Marco Mendicino, Minister of Public Safety, about Bill C-21, and how it reflects what he learned when he met with firearm owners in the Yukon.

Dear Premier,

Thank you very much for your attendance at the 2023 Annual General Meeting of the Association of Yukon Communities.

At this meeting our membership passed eight resolutions. I did, however, want to bring your attention to one in particular that was co-sponsored by several municipalities and was passed unanimously by our members. The resolution relates to the need for respectful engagement and communication from the Government of Yukon.

While several representatives of the Government of Yukon were present during the discussions on this particular item in an observer capacity - considering the nature of the comments I felt it was necessary to write you directly to raise some of the concerns of our membership.

In recent years several of our members have noted a trend in which the Government of Yukon develops or implements policy that has impacts on local governments. While we appreciate that the Government of Yukon at times must make changes to legislation or policies it must also keep local governments involved in this process. This is particularly the case in instances where the policy changes have financial or administrative impacts on us. Our members play an essential role in the delivery of services for Yukoners, and it is not sustainable in the long-term to not include the Association of Yukon Communities and our membership at the ground level of any policy development that impacts us.

Currently the Municipal Act requires that the Government of Yukon must consult with the Association of Yukon Communities on any direct amendments to the Act. While this is explicitly outlined in the Act, it is up to the Minister responsible to ensure this is followed and this has not always been the case. During the discussion on this resolution our membership made it clear that they would like to see the wording around this section of the Municipal Act strengthened.

One of these resolutions relates to lapses in emergency medical services in municipalities, the need for improved communication from the Government of Yukon with municipal governments during these lapses, as well as the lack of proper compensation for municipal governments when they are called upon to assist during these lapses in service.

As you know, EMS is an essential frontline service made up of hardworking first responders who go above the call of duty and at many times are at risk of burn out. Without a sustainable model for staffing, training, and compensation for EMS personnel we are concerned about further negative impacts on coverage in our communities.

As such we are requesting that the government ensure 100% EMS coverage in Yukon communities and if that is not possible, request the consideration of alternative delivery models. We further request that if municipalities are called upon to assist EMS personnel, they are fully and promptly compensated. We are also requesting that the Yukon Government review the current EMS volunteer model as it's been in place for some time, look to increase honoraria and standby pay, and fully pay for training. Finally, we would like the Yukon Government to develop and implement a communication protocol for communicating with communities about lapses in EMS service.

For your reference I have attached the resolution that passed unanimously. Thank you for your consideration in these matters.

Re: Resolution concerning Emergency Medical Services

Thank you for your letter of June 7, 2023, regarding the resolutions passed by the Association of Yukon Communities at your most recent Annual General Meeting. I appreciate you reaching out about these resolutions regarding Emergency Medical Services coverage, service models, compensation, and communication with communities.

I understand that the Director of Emergency Medical Services, Gerard Dinn, is working with the municipality of Dawson City to address these areas of concern. I believe this work can be leveraged with other communities. If communities would like to discuss their concerns directly, I encourage them to connect with the Director to discuss local issues, needs, the role of communities in relation to EMS, and opportunities for collaboration. Please know that I have also shared these resolutions with the Department of Health and Social Services and EMS for further consideration and review. If you or your members would like to discuss these issues, the Director is available at Gerard.Dinn@yukon.ca or by phone at 867-456-6591.

The reality of living in a remote area such as the Yukon is there will always be challenges to maintain staffing in remote geographical areas and added low call volume make recruitment and retention an on-going challenge. In 2022, Yukon communities had full EMS coverage 68% of the time, while EMS in Dawson City and Watson Lake had full coverage approximately 95% of the time or higher. All communities, including Whitehorse will experience gaps in local coverage. EMS strives to reduce these situations as much as possible.

Primarily, these gaps occur as a result of a surge in call volume and staffing challenges. To achieve the highest possible coverage, EMS maintains on-going recruitment, retention and training programming, uses online scheduling software which allows for real time scheduling. EMS will shift responders from neighboring stations including Paramedics from Whitehorse, Dawson City and Watson Lake when operational feasible. EMS is currently hiring four Paramedic Floats and these positions are focused on supporting EMS outside of Whitehorse. When EMS receives a request for service when there is no local coverage available, then EMS, when possible, utilizes neighbouring stations, explores alternative transportation and in rare situations, deploys an air ambulance to ensure access to ambulance services.

I appreciate that municipalities have questions about their roles and responsibilities in these situations, as well as access to communication on when coverage may be limited. While EMS' approach to working with municipalities is consistent with approaches and relationships in other jurisdictions, I recognize this is a source of concern to municipalities and I welcome you to continue these conversations with the Director of Emergency Medical Services.

EMS maintains on-going efforts to recruit and retain staff and community responders to maximize the number of positions that are filled. To assist with recruitment, all aspects of on-boarding community responders is funded. I recognize that communities are concerned with the potential risk of staff and community responder burnout, and I assure you that we take the health and wellbeing of all who support the delivery of EMS very seriously.

Thank you again for writing to share these resolutions with me and for your advocacy on behalf of Yukon communities. If you have any further questions, please do not hesitate to let me know.

Dear Ted Laking,

The Premier asked me to respond to your June 7 letter regarding resolution 23-AT-05 from the Association of Yukon Communities (AYC) Annual General Meeting (AGM). I note that alongside the resolution members passed at their AGM, you have made a separate recommendation regarding additional parameters around conversations between myself and municipal leaders.

The Government of Yukon takes the partnership agreement with the Association of Yukon Communities, and the commitments to promote engagement and cooperation between the parties, very seriously.

As you know, the Director of Community Affairs and the Executive Director of the Association regularly meet to discuss mutual priorities and concerns, and to share information. The Government of Yukon considers this bilateral commitment as an essential opportunity to ensure local governments are aware of territorial government policy changes or developments that impact them.

The Community Affairs team raises awareness about Municipal Act requirements across Yukon government departments. They advocate the value of engaging with local governments when conducting policy work, especially in legislation or policy that is tied to municipal work and responsibilities.

To ensure communities are consulted and their voices are heard around the Cabinet table, I have periodic one-on-one discussions with mayors. I can say these conversations have provided mayors with the opportunity to raise issues directly with me while also ensuring strong bilateral relationships exist between the Yukon Government and municipalities across the territory. I have ensured they all have my personal cell number and have encouraged them to call me anytime about anything they wish to discuss.

With respect to the introduction of new criteria limiting how I am to engage with communities, which was raised in your letter to the Premier, but was not part of the resolution passed by AYC's membership, the Government of Yukon is concerned that adding restrictions to the aforementioned engagements would limit opportunities for frank, respectful dialogue between our two levels of government. However, if it is the will of the AYC membership, we would encourage you to bring forward a resolution at your next AGM.

As Minister of Community Services, I am committed to fostering a respectful, inclusive, collaborative working relationship with Yukon municipalities and the Association of Yukon Communities. We will continue to ensure that communications with municipalities are timely and respectful of the role local governments provide Yukoners.

Thank you again for your letter and your attention to this important topic. Congratulations on a successful 2023 AGM.

I wish to make a proposal for an art project that will encourage ongoing involvement of Haines Junction artists and residents as well as engage tourists and visitors to Haines Junction. I wish to apply for funding for the project as an individual through the Prize 125 Fund introduced by the Yukon Government. In order to receive funding for the project, I would first need approval of the plan from Mayor and Council as it would be installed on Village property. Here is my idea:

I would like to propose a series of small, unique and creative house-like structures on posts similar to (but not exactly like) those used as mini libraries all over the world. These permanent structures would house changing art displays, installations, miniature museums, dioramas, toy sharing sheds, puzzle exchanges, libraries and other miniature creative and interactive stops of interest and would be situated around our community. The houses would be plotted on a fun and visually appealing map that would be available in a printed version, posted in public locations and available on line. The structures would be designed to be aesthetically pleasing and built by local craftspeople meeting certain specifications. I would keep the project simple. These houses would create stops of interest and an incentive to walk around our community while highlighting some of the art and craft that exists in our community and providing interactive destinations for community members and visitors.

The deadline for the application for Prize 125 is August 4th, 2023. There is a one year window to complete the project.

If you agree that this would be an acceptable and interesting addition to our community, I would appreciate a letter of support soon so that I can begin the application process. It is my intent that the construction and installation costs of the project would be covered by the Prize 125 award, but I am asking if Public Works staff could undertake the annual maintenance of these structures.
