#### RE: Invitation to Engage on the Animal Protection and Control Act Regulations

I am reaching out from the Department of Environment, Government of Yukon with regards to the new Animal Protection and Control Act which received assent during the 2022 Fall sitting of the Legislative Assembly.

The Animal Protection and Control Act is a comprehensive, modern and enforceable legal framework for managing all aspects of animal protection and control in the Yukon. This new legislation will replace the current Animal Protection Act, the Dog Act and the Pounds Act. The new Act addresses longstanding concerns of Yukoners about enforcement of animal laws and will mitigate risks that uncontrolled animals pose for public safety, the environment and property. It also raises the bar for animal welfare across the territory

As I mentioned during the 2022 Fall sitting, the Government of Yukon would like to continue to engage with key stakeholders on the development of the regulations under the Animal Protection and Control Act. We would like to discuss with your community the plans for enforcing the new legislation, as well as ideas for tools to control feral animals in and around your community.

Environment staff are available and motivated to work with you and community officials to host a meeting in your community to hear your citizens' views. If possible, we would like to meet between April and July 2023. If it would be more convenient, we are happy to host a meeting in conjunction with other events happening in your community. If you would like to arrange a meeting we would appreciate your advice on event design and logistics.

I am writing this email as an appeal to you because you represent one of the most inspiring communities for environmental advocacy on our planet. There is an international campaign underway to move our earth in the direction of something called **'Dark Sky Status'** as a means to protect the environment by tackling light pollution. Currently, it has united approximately 200 places across the planet to officially protect over 110,000 sq km — including communities, parks, reserves, islands and sanctuaries. And your community's unique position in the northern latitudes makes it perfect for uniting with, as well as benefiting from, this global action.

#### What is The Dark Sky Movement?

The <u>International Dark-Sky Association</u> (IDA) is the recognized leading authority on combating light pollution worldwide. It provides leadership, tools and resources to reduce light pollution and promote global environmental responsibility by discouraging the destructive impact of light pollution.

#### What are the Effects of Light Pollution?

With global light pollution having risen by at least 49% over the past 25 years, the large range of environmental and human impacts include the following:

- <u>Wildlife</u>: impacting animal behaviours, migration, habitat formation, and sleep cycles
- Pollinators: interfering with ecological survival and vital food supplies
- Environment: affecting natural habitats
- <u>Human health</u>: resulting in sleep disorders, diabetes, depression, heart conditions, breast cancer, etc.
- <u>Climate change</u>: accounting for 20% of the world's electricity use and 2 billion tons of carbon per year

#### How Can Your Communities Benefit by Joining the Dark Sky Movement?

By fostering conservation and environmental education, the Dark Sky movement is uniting communities around the world through this public awareness campaign. An interesting benefit to having 'Dark Sky Status' is that it can be used to promote regional economic interests as well. And with your communities being situated so far north, businesses can become involved in the rapidly growing tourism niche that relates to astro-tourism for stargazers and Aurora Borealis hunters. Having this environmentally-conscious status can also enhance the marketing of local hotels, bed and breakfasts, campgrounds and restaurants.

The Yukon 125 Fund makes \$400,000 available to Yukon First Nation governments, Yukon municipalities, community organizations, clubs, boards and committees in support of commemorative projects, events and activities. Each successful applicant is eligible to receive up to \$7,500.

# Yukon 125 Fund

# Fund Guidelines (\$400,000 available)

**Purpose:** To commemorate the anniversary of Yukon becoming a territory, and honour the Yukon's communities, heritage and culture.

The Yukon Historical & Museums Association (YHMA) is pleased to participate in this unique opportunity for communities to recognize the territory's shared cultural heritage and tell the Yukon story from multiple perspectives. Yukon 125 calls on us to use the knowledge of the Yukon's past – beginning millennia before 1898 and continuing to the present – to build a stronger future. Yukon 125 is an opportunity to both celebrate and reckon with our past. Your projects and events will not only serve as an invitation to engage with our Yukon history, but also as a call to action for us all to play a role in our collective future.

**Application intake period**: May 1 to June 30, 2023 or until funding is allocated, whichever is first. An extension may occur subject to funding availability.

**Eligible automatic recipients**: Yukon First Nation governments, Yukon municipalities (up to \$7,500).

**Eligible applicants**: Organizations, clubs, boards, committees that are Yukon-registered societies in good standing. Partnerships between non-registered groups and Yukon-registered societies are eligible (up to \$7,500).

**Ineligible applicants**: Businesses, for-profit enterprises, individuals, societies in non-compliance with the *Societies Act*.

#### **Eligible activities**

- Celebrations, community events, gatherings, forums that are free and open to the public.
- Improvements to Yukon community spaces. Some examples include signage, park and playground infrastructure, landscaping, art installations, murals.
- Creative projects and performances showcasing Yukon.
- Research or educational projects that focus on Yukon's heritage, culture, history.
- Projects must occur between June 1 and October 31, 2023.
- Components of larger and existing projects are eligible. However, the funding application must relate only to that specific project component.

Likely only one application per government or organization will be considered.

If your project will be taking place in a community other than your own, please include a letter of support from that community or an appropriate community group with your application.

#### **Ineligible activities**

- Large capital purchases. Some examples include vehicles, building construction, real estate, heavy machinery.
- Expenses incurred prior to June 1, 2023 or prior to application submission, whichever is later, or after October 31, 2023.
- Fundraising activities, awards, sponsorships or re-funding activities.
- Religious activities.
- Projects that promote hatred or intolerance.
- Activities that contravene territorial or federal law.
- Payment of taxes owed by an individual or organization.

#### **Payments**

Each successful applicant will be required to enter into a funding agreement with the YHMA.

The agreement will detail the activities approved for funding and the terms and conditions of

that funding, 90% of the approved funding will be advanced to the applicant after the project

funding agreement is signed. The remaining 10% of the funding will be held back until the final

project report has been submitted.

**Recognizing funders** 

Recipients are to give funding credit to the Yukon government using the Yukon 125 logo in

each occasion there is an opportunity to do so. This logo will be provided in a digital format by

YHMA to funding recipients.

Reporting requirements

Reporting requirements and deadlines will be articulated in the funding agreements. All funding

recipients shall provide a final financial report for the project that includes revenues and

expenses.
