Report to Council Village of Haines Junction Open Meeting April 26, 2023

RE: 2023 Haines Junction Yukon Lottery Funding Grant Distribution

Recommendation

1) That Council adopt a resolution awarding the following Haines Junction Lottery Funding Grants from the April 17, 2023, intake:

THAT Council for the Municipality of Haines Junction award the following Haines Junction Lottery Funding Grants:

• Haines Junction Football Club: \$1,940.00

• Treble Makers Fiddle Club: \$2,025.00

• Creative Junction Collective: \$4,062.91

• St. Elias School Bouldering Club: \$2,950.00

Funds Available

The allocation of Community Lottery Program funds from Lotteries Yukon is \$23,493.00 for the 2023/24 fiscal year.

April 17, 2023 Intake

Ellen Stutz (Receptionist), Rob McPhie (Parks and Recreation) and Yari Izigzon (Corporate Administrator) reviewed the six grant applications received for this round of funding.

The total of requested funds was \$\$36,236.04 as follows:

- Haines Junction Football Club: \$1,940.00 for soccer balls, pop-up soccer nets, pinnies, storage locker, travel expenses for coaches from Whitehorse to support player and coach development.
- St. Elias School Bouldering Club: \$2,950.00 for completion of 40ft. bouldering wall. In need of mats and holds for 20ft. to complete the whole wall.
- Treble Makers Fiddle Club: \$2,300.00 for in-person individual fiddle lessons with professional instructor Keitha Clark from Whitehorse.
- Creative Junction Collective: \$7,925 for children's dance program costs
- St. Elias Cross Country Ski Club (SECCSC): \$1,024.79 for brushing and a popcorn machine.
- BGC Yukon & CAFN Youth Programs: \$20,096.25 for specialty camps (3-day Skateboard workshop and 4 day softball/baseball skills camp).

In allocating this funding, the reviewers determined the applicants' eligibility based on the conditions outlined in the Haines Junction Lottery Funding Grant Information Sheet. The funds were allocated proportionally based on the strength of the application and program. The following applications were not recommended for approval:

- St. Elias Cross Country Ski Club (SECCSC): The application asked for a lesser amount from the
 brushing quote that SECCSC received. Administration was contacted by the St. Elias Cross
 Country Ski Club passed the deadline to request the higher amount of \$7,324.79 to cover both the
 brushing and popcorn machine. Administration and SECCSC decided that it would be best for
 them to defer the application for the fall intake as their needed request was submitted past the
 deadline.
- BGC Yukon & CAFN Youth Programs: The application included wages to hire staff for the
 workshops plus equipment. Wages are an ineligible expense for the Lottery Funding Grant.
 Administration decided that due to the ineligible expense of wages and Council's current
 discussion for the funding of requested recreational equipment submitted by BGC Yukon, in
 collaboration with CAFN Youth Centre, the application be withheld from funding.

It is important to note that the demand for this grant funding has increased significantly in the past few years, and the majority of applications come forward at the October intake. Most applications are not able to be fully funded as the applications far exceed the amount of funding available. As such, the reviewing committee did not feel comfortable allocating too large an amount of the total funding to this first intake.

At the April 27, 2022 Council Meeting, Council passed the following resolution due to Administration's suggestion to conduct a review of the grant funding regulations, including intake dates and application criteria, in order to provide a more fair and equitable allocation of the funding to all community groups.

#124-22 It was moved and seconded

THAT Council request Administration to explore policy and program options and provide a report for consideration of changes to the Haines Junction Lottery Funding Grant criteria and allocation methodology beginning in 2023.

Motion# 124-22 was CARRIED.

Administration has looked into the requirements of other Municipalities and decided that it was too late to change them for the 2023 fiscal year. However, Administration will bring a report forward to Council with possible changes that would indeed provide a more fair and equitable allocation of the funding to all community groups, and perhaps individual applicants.

Conclusion

By awarding the above-noted Haines Junction Lottery Funding Grants, Council will be supporting recreational, artistic and cultural programming in our community.

Report to Council Village of Haines Junction Open Meeting April 26, 2023

RE: BGC Yukon Request for Summer Programming Funds

Recommendation

That Council review this report and make a recommendation on whether to provide funding to the BGC Yukon for the 2023 Summer Youth Programming and any contributions to the Participaction Community Challenge.

Background

At the April 12, 2023 regular meeting, BGC Yukon made a presentation to Council regarding 2023 Summer Youth Programming. The total amount requested is \$61,930.80. There is \$75,000 allocated in the 2023 Capital and Projects Budget for Recreational Equipment and Programming. Funding provided to BGC Yukon in 2021 was \$49,239.00 and \$53,675.56 in 2022.

This year's funding request includes \$10,005.00 (plus 15% Admin fees) for hiring a lifeguard / instructor to provide supervised swimming and lessons at Pine Lake. BGC noted that they would prefer if Council would hire the lifeguard directly as a Village staff member. Pine Lake is outside of the municipal boundary and is under the jurisdiction of YG Parks. Our insurance advisor has noted that our insurance would cover this liability but cautioned that we should consider whether it would be an acceptable new risk as any claims filed could have a substantial impact on future premiums. YG Parks has advised that their boundary does not include the water but does include the land that the lifeguard would be stationed on and would need to seek further input from YG's risk management department. There is also the question of availability of certified lifeguards, and what special certifications may be needed for a cold lake waterfront location.

BGC Yukon is also requesting \$2,283.75 for the purchase of 15 long boards, helmets and padding.

BGC Yukon has received a grant for the Participaction Community Challenge. They are requesting in kind contributions of arena space, poster printing, labour time, material to build a community engagement "thermometer", and funds to purchase laser tag equipment (no cost has been provided). BGC noted that they would like to do laser tag in the arena and would not require a Village staff member to be present. While our insurance advisor has noted that we wouldn't need a staff member on site, we could be liable for any claims for injury if we could be proven negligent. Our insurance for user groups will not cover laser tag and we cannot guarantee staff availability to accommodate BGC's potential schedule.
