Accounts Payable to February 26, 2025

Topic: Comprehensive Municipal Grant (CMG) Update

A/CAO Presentation:

 There has been a fair amount of advocacy in recent years by the Association of Yukon Communities to see the Comprehensive Municipal Grant (CMG) increased

- AYC released a report several years ago providing rationale for why the grant needs to be increased (e.g. increasing regulatory requirements, impacts of climate change, expansion of municipal programs and services, etc.)
- The CMG formula does reflect cost of living increases. This year, the Village is receiving a 9% bump to our grant beyond inflation. This is a significant increase.
- The CMG accounts for almost 70% of the Village's revenues.
- The increase we received in absolute dollars is \$316,455 over last year.

Discussion:

- There was a committee at AYC that put a lot of effort into this.
- Population is a key factor in the CMG grant formula. One community (Faro?) did its own
 census because they didn't feel Yukon government's numbers were correct. This work led to
 all of the AYC delegates wanting to know more about how YG gets its numbers.

Request for Memorial Bench to honor long-time resident Joann Graham A/CAO Presentation:

- This request, from the Graham family, is to place a memorial bench in her honor.
- A few locations that would be more meaningful to the family were noted, the first being the path along the Alaska Highway between the intersection with the Haines Road and the weigh scales. Alternately, the path to Source motors, or towards Pine Lake.
- The family indicated they would be happy to put a plaque on an existing bench or to have a new bench built and they indicated they didn't expect the town to cover any of these costs, they are just looking for permission for a location.

Discussion:

- Joann worked at the weigh scales so the path to the weigh scales would be a great location, there are two benches at the weigh scales
- Shortcomings along the trail for people with disabilities have been noted by Access
 Canada there is no bench between the airport road and Pine Lake. This is too long a
 distance to walk without a bench.
- Ensure Public works is consulted regarding snow plowing/grass cutting considerations.
- Ensure approval is sought from Highways for benches to be placed within Highway right away.
- Ensure request from Monica Primozic was finalized.
- Instead of multiple benches, consider one bench with multiple plaques, so we don't have too many benches. The Millennial Trail in Whitehorse has benches with multiple plaques on a bench.

THAT Staff further explore locations with Highways and Public Works, consider advice from Access Canada to locate benches between the airport road and Pine Lake, inform the Graham family that they may either put up their own bench or put a plaque on an existing bench, and send a letter to the Graham family confirming Council's support for their proposal.

- Has sat in on council meetings held in other communities.
- Participated in ice-fishing event put on by Champagne Aishihik First Nation at Dezadeash
 Lake that all were welcome to attend.

Councillor Busche

 Attended awards night for Haines Junction Minor Hockey held earlier this evening. Rob and Patty Moore received the Grandparents Award for all the work they contributed to Minor Hockey.

Deputy Mayor Strand

- Attended Mayor and Chief's Forum on February 19 in Whitehorse. All municipalities attended, along with 7 First Nations in attendance
 - o Presentation from Animal Health Unit (AHU) inquired about commitment made to staffing regional animal control officers that had been promised by the previous Chief Veterinary Officer. Current AHU staff were not aware that this commitment had been made. Commitment was made during a Committee of the Whole (staff to look for minutes so these can be shared with the AHU).
 - Presentation from Public Safety and Investigations in the Department of Justice -SCAN (Safe Communities and Neighbourhoods) Act is under review. This Act used to focus on the home, now there is a desire to focus on the people within

- the home. We heard that organized crime is prolific in Yukon. Gladue reports where a Judge needs to consider the upbringing of Indigenous offenders -- were discussed. RCMP now have a psychologist on staff to assist with de-escalation.
- Presentation on Emergency Preparedness highlighted the importance of having civic address signs posted. Still a lot of these signs at the Village Office that have not been picked up by community members.
- Municipal Boundary Expansion Expanding boundaries to include voting for self-governing First Nations will be relatively easy to address; taxation will not be easy to address. First Nations want taxation to go to municipalities and not to YG; will require a service agreement between Yukon government and municipalities to transfer these funds to municipalities. Chiefs and Mayors were unanimous in desire to continue to push this forward.
- Telephone discussion with Haines Mayor Morphet. Wants to come and visit. Wants Canada to stay Canada and for our communities to remain good neighbours.
- Mayors met with Premier regarding tariffs. Mayors were updated on what Yukon government is doing to address tariff issue. Advised to consider this in next budget cycle e.g. if doing a major construction project or any major procurements if items are sourced from the US. Trump delayed to April 5th earlier today.
 - O Notice of Motion ask staff to look at the major things that we purchase on an ongoing basis and to see if we have options to purchase elsewhere if we purchase from the US. Need more research on what our position is regarding tariffs. Report for Council for next meeting so Council is more informed. We are a border town, also look into what the Border City Mayors Alliance is.

• This proposal was sent to Council in confidence. Commercial proposals are held in confidence because they are the intellectual property of the business. Should Council accept the proposal it would be in the public domain.
