# RTC - 101 Hume Street and Lot Sale Process

Materials provided: RTC

#### CAO Report:

- This report was a late addition to the package.
- This report follows up on the report presented to Council on May 8<sup>th</sup> regarding 101
  Hume Street. Council requested additional information on the process for how 101
  Hume Street was identified for sale.
- In June 2023, the Land Development Branch (LDB) reached out to the Village seeking
  lots in the community could be placed on sale. LDB provided an initial map of vacant
  lots. Several of these lots were removed from the list for various reasons including right
  of way issues, protracted development requirements and conflict with seasonal
  waterways.
- On July 12, 2023 Council Meeting, Council directed staff to proceed with the YTG lot sale initiative as directed (Motion #194-23). Specifically, 101 Hume Street, and Lots 206 & 208 Luciana Street. 111 Hume Street and the Industrial Lot were also recommended for consideration.
- Appended to the report are the considerations from the Board of Variance regarding 101
   Hume Street.

#### Discussion:

- Luciana Streets are currently serviced from the alley and are not currently sanitary serviced this would be done when put up for sale.
- Could 206 and 208 Lucania also be captured in the motion?
  - Yes, this would be helpful to staff.
- YG lots need a larger discussion should we wait to release YG lots for sale until all YG lots are ready?
- Council is reluctant to pass a motion without the Mayor being present.
- Would like to see a report on all the lots: 101 Hume Street, 111 Hume Street, an industrial lot and Lots 206 & 208 Luciana Street.
- Suggest scheduling a Committee of the Whole meeting and include a discussion about potential options around Kluane Street.

# RTC - Spring Litter Cleanup

# Corporate Manager Report:

- Spring litter clean-up in Haines Junction has been coordinated and supported in a variety
  of different ways by a variety of organizations over the years.
- There has been some inquiries from residents asking when litter pick-up will take place, and some confusion/concern expressed about HPW coordinating clean-up along the highways through town this year instead of the Village.
- Staff have reached out to CAFN to see if they are planning to coordinate anything.
- YG Highways and Public Works (HPW) have assigned all the highway clean-up sections in and around Haines Junction to community groups through their Spring Litter Clean Up Campaign.
- Last year, and the year previous, HPW did not coordinate the clean up along the highway through town as this was funded through the Trans Canada Trail Foundation. They included the section through town at the request of the Village.
- Three options were presented to Council for how the clean-up could be approached this year. Staff recommend:
  - o Dividing the town into six roughly equal sections,
  - Providing grants to eligible community organizations in the amount of \$250 per section,
  - o Establishing eligibility criteria per the Donated Refundables Fund.
  - Assigning groups a maximum of 2 sections unless not enough groups come forward within two weeks of posting this opportunity, at which time willing community groups may apply for as many sections as they feel they can take on.

#### Discussion:

- Council is supportive of all the options.
- Regarding the option to encourage residents to clean up the community and hosting a
  community BBQ -- garbage bags could be left on the side of the streets for Public Works
  staff to clean up as has been done in the past.
- Option 3 (as recommended by staff) provides consistency with how the Highway roadside is being cleaned up and wouldn't put extra work onto staff to organize a BBQ.

# RTC - Naming of Willow Acres Area 1 Infill

#### CAO Report:

- Staff are seeking Council direction on the naming of the Area 1 subdivision whether there is a desire to give it a name, and if so what name.
- Consultation took place during the Master Planning process. The community expressed a
  preference for a name that reflects the natural environment, be written in Southern
  Tutchone and English, and pay homage to the CAFN traditional territory. Many potential
  names for the subdivision were suggested.
- Council has reviewed guidance provided by the community and have narrowed down potential names to:
  - Dhäl Gähy (roughly translated to Mountain Ridge)
  - o St. Elias Vista (translation pending)

#### Discussion:

- Dhäl G\(\frac{2}{4}\) (Mountain Ridge) is preferred because it the subdivision has a wonderful view of the mountains.
- The spelling was drawn from the Southern Tutchone dictionary. Will need to confirm spelling.
- Considered just naming the streets and not naming the subdivision. Council expressed a
  preference to give the subdivision a name so we can move away from calling this Area 1.

#### #143-24 It was moved and seconded

**THAT** the Council direct staff to officially name the Area 1 infill development as Dhäl Gähy, roughly translated to Mountain Ridge, with a check in on the spelling.
